

# Terms & Conditions: York 10K 2024

## (Own Place)

### **Entry Fees & Sponsorship Target**

- As you have covered the cost of your participation in this event, there is no entry donation to be paid to York Mind.
- You have indicated that you wish to fundraise for York Mind. There is no minimum sponsorship target for this event; however, any sponsorship you do raise will be greatly appreciated, and should be received in full by the charity within 4 weeks of the event date.
- All funds raised from your participation in the York 10K 2024 should be paid to York Mind in £ sterling, and the aim is for you to raise as much as possible.

#### **Entry Process**

- 1. Participant signs up online.
- 2. Terms & Conditions & Sponsored Event Agreement documents emailed to participant after confirmation of fundraising for York Mind.
- 3. Participant emails completed Sponsored Event Agreement back to York Mind.
- 4. Once returned, a Fundraising Pack and monthly emails are sent out to the participant until the date of the race.

### All participants

- You confirm that you are medically fit and that you participate in the event at your own risk. York Mind will not be held responsible for injury or illness resulting from your participation.
- You understand that it is your responsibility to read any terms and conditions issued by the race organisers and to comply with these.
- The minimum age for this event is 15. You confirm you will be the minimum age on race day.

- You acknowledge that York Mind incur costs as a result of you joining Team York Mind (e.g. cost of your entry place, producing and sending fundraising pack) for this challenge. The objective is for you to raise as much sponsorship as possible.
- Should you, for whatever reason, not take part in the race, all sponsorship raised must be offered in return to your sponsors. If they do not wish for a refund, the funds must be paid to York Mind.
- You have provided York Mind information about you and consent to York Mind using this data. You understand that it will be necessary for York Mind to share the data with the race organisers in order to participate in this event.
- York Mind do not sell or swap your details with any third parties, but in order to carry out our work we may need to pass your details to service companies authorised to act on our behalf.
- York Mind will keep your details on our database so we can provide you with the best possible support every time you contact us.
- All participants, supporters and spectators confirm that they are happy for their names, video footage and photographs taken of them during the event to be used by York Mind for commercial and fundraising purposes including, but not limited to marketing material, television broadcasts, social media, advertising, publications, and other documents or mediums that may be made available to the public. Photographs of children will not be used in this manner without express written consent; unless the images are incidental, for example, children's images at the starting line.
